13 years ago, Ticiea was living in South Minneapolis in an apartment contaminated with lead paint.

Her children, Logan Jessica and Dustin Luke, were both poisoned by the lead.



Her faith called her to make sure that this does not happen to another child. She has been a tireless advocate for Lead Safe Homes legislation at the State Capitol. "I have given up many times, but every time God does a new thing in my son's life. It's like a push from him, telling me to keep going. I'm not going to stop until I win."









Lead exposure is dangerous for young children and can cause permanent brain damage.



- ■ It costs \$2,500/unit to make a unit LEAD SAFE from lead paint hazards.
- ♠ A child disabled by lead poisoning may utilize \$100,000 per year for the rest of their life in State, Federal, and Medicaid benefits.
- This bill allocates \$1 million/year to ensure more lead-safe homes in urban and rural areas.


