

Crossroads to Justice Plan

- On October 27, Interagency Council on Homelessness approved Crossroads to Justice Strategic Plan.
- The plan was co-developed with 10 paid consultants with lived experience of homelessness.
- It focuses strategies and actions the state can take to achieve five bold results.





Accepting Applications for Implementation Consultant

- The Minnesota Interagency Council on Homelessness has contracted with Rainbow Research to support consultants that will help guide the implementation of Crossroads to Justice.
- Rainbow Research hiring 14 people who have experienced homelessness to join the implementation consultant group. Consultants will be paid \$60/hour for up to 25 hours of work per month.
- Rainbow strongly encourages individuals who are Black, Indigenous, Latinx, a person of color, LGBTQIA2S+, with a disability, and/survivors of domestic violence to apply.
- Rainbow is looking for people who are passionate about helping shape the way the state deals with the root causes and current needs of Minnesotan's experiencing homelessness.

Budget Implementation Updates: Office of Economic Opportunity (OEO)

- Awarded \$100.5 million in the combined RFP awarded to 135 applicants (received \$285 million in requests). This is an increased in funds from \$35 million in FY 22-23.
 - Includes the Emergency Services Program (ESP), Emergency Solutions Grant (ESG), Transitional Housing Program (THP), Homeless Youth Act (HYA).
- 45% of funding awarded in greater Minnesota and 55% awarded in metro
- New and expanded programs include:
 - Culturally-specific motel vouchers and services in St. Paul, Willmar and Austin
 - Day shelters in Minneapolis, St. Paul, Faribault, Mankato, Bemidji and International Falls
 - Overnight shelters in Hibbing, Anoka, Bois Forte, Marshall, Mankato, Minneapolis & St Paul
 - Many providers increasing staff ratios, training, and mental health support to improve housing outcomes

Budget Implementation Updates: Office of Economic Opportunity

- Emergency Shelter Facilities/Capital awarded \$100 million (received \$365 million in total requests)
- 47% of funds were allocated to greater Minnesota; 53% were allocated to the seven-county metro area.
- Anticipate* 373 beds will be added and 376 will be preserved, maintained, or improved in greater Minnesota; 218 beds will be added and 348 will be preserved, maintained, or improved in the metro.

*Subject to change. Currently working with providers to finalize workplans/budgets. Once all contracts are in place, the list of funded entities will be publicly available.

DHS Changes to Adult Income Support

- The General Assistance community standard is increasing from \$203 to \$350 per month beginning 10/1/2024 and will increase annually with inflation.
- Housing Support recipients in most supportive housing settings will now be responsible to pay only 30% of their unearned income like SSI, RSDI, and VA benefits beginning 10/1/2024.
- People releasing from DOC facilities with a certified disability or disabling condition will have access to up to three months of eligibility for Housing Support with no countable income.

Minnesota Housing: Consolidated RFP Recommendations

Over **\$275 million** in <u>state</u> appropriated resources were selected at the December 14 Board meeting

- Rental: Housing Infrastructure, Challenge, Preservation (PARIF)
 - 28 rental properties this year, with 13 located in the Twin Cities metro and 15 in Greater Minnesota.
 The multifamily rental selections support a total of 1,486 units
- Homeownership: Housing Infrastructure, Challenge, Workforce Homeownership
 - 78 projects supporting a total of 1,314 homes. Of these, 278 homes are new construction, and 598 will be rehabilitations of existing homes.
- Manufactured Housing: Housing Infrastructure, Manufactured Housing Redevelopment/Infrastructure
 - \$21.5 million allocated in selections

Coupled with other resources this will create or preserve over 5,000 units.

Minnesota Department of Veteran Affairs

- Operation: OVER (Opening Veterans to Every Resource)
 - Over \$131,000 in rental or mortgage assistance payments; \$32,000 in security deposit assistance; \$219,700 paid in landlord incentives including broadening screening criteria
- Minnesota Veterans Entering Stable Tenancy (MNVEST)
 - \$3.2 million in Veteran rental assistance; currently 120 Veterans receiving rental assistance
- Veterans Supportive Housing Options (VHSO)
 - 130 rental units secured with the funding
 - 48% decrease in Chronic or Long-Term Homelessness
 - MDVA controls access to ensures Veterans being screened are within priority group; 100% of Veterans screened through a screening rubric to track rental and Justice Involvement history, divert anyone who doesn't have high barriers to other rental units

One Minnesota Housing Stability Budget

The Governor has signed an interagency budget for housing stability that is biggest investment in housing and homelessness in state history! At over \$2.6 billion dollars across the next four years, it will have transformative impacts on the continuum of housing needs from preventing and ending homelessness, to creating a healthy rental market for low-income renters, to closing the disparities in homeownership.

Housing Stability Budget Summary

Crossroads to Justice Strategic Plan

On October 27, 2023, the Minnesota Interagency Council on Homelessness, led by Lieutenant Governor Peggy Flanagan and made up of the Commissioners of 14 state agencies, committed to Crossroads to Justice: Minnesota's New Pathways to Housing, Racial and Health Justice for people facing homelessness. The plan is the culmination of a year-and-a-half-long process that was co-led by 10 paid Justice Consultants, all people with lived experience of homelessness representing different experiences and different parts of the state.
