**Catholic Charities Dorothy Day Place** is an integrated two-building campus designed to prevent and end homelessness by focusing on three components: dignified shelter, permanent homes, and dedicated services that will create pathways to opportunities.

Emergency shelter services provided through the Higher Ground St. Paul Shelter and St. Paul Opportunity Center are a critical part of the region's homelessness response system. Higher Ground St. Paul Shelter operates more than 55% of the emergency shelter beds for single adults in Ramsey County, and the St. Paul Opportunity Center helps nearly 500 unique individuals each day meet their basic needs and access services.









#### **Catholic Charities Twin Cities**

- Housing, emergency shelter, and direct services provider serving 20,000+ children, families and adults each year
- More than 10,000 seek services at our 4 overnight emergency shelters and 2 daytime service centers
- 550,000 nights of housing and emergency shelter annually
- Nearly 1.1 million meals served
- Rooted in the community for 150 years

- An estimated 1,500+ individuals use SPOC as their mailing address





Innovative grassroots housing organizing is going on across the city of St. Paul. The East Side Freedom Library hosts the East Side Housing Justice campaign (Sidney); the Greater East Side District Council (D2) has direct tenant organizing (Giovannia), and the Purple People campaign (Paris) brings together faith, business, neighborhood and transit advocates to support the Purple Line Bus Rapid Transit, which connects directly to affordable housing and community revitalization.





# ABC Realty, East Side Freedom Library, and the beginning of our work

In February 2019, ABC Realty began researching the state of housing in Minnesota, and on the East Side. We found a number of alarming figures throughout the housing market, highlighting the long-lasting effects of discriminatory policies and practices. We also found a shortage of affordable housing.

 Throughout Minnesota, 75% of white Minnesotans own their homes, while the number of people of color who own their homes is about 25%.

• On the East Side, the number of renters and homeowners who are cost-burdened by their housing is around 45%.





#### Three Important Metrics:

Area Median Income:

The median income for the entire metropolitan area

Difficulty in Saint Paul

Age of the home:

Older homes need to be renovated

Cost-Burdened:


A household is considered to be "cost-burdened" if housing costs consume more than 30 percent of household income.
























A year ago, in this building, the Council rolled back major protections in the City's Rent Stabilization Ordinance, exempting new construction and affordable housing when the voters chose otherwise.

City Hall is also home to the Mayor's office. Under his supervision, the Department of Safety & Inspections has chosen not to enforce violations of the Ordinance against landlords breaking the law.

## Metropolitan Interfaith Council on Affordable Housing

### MINNESOTA POLICY



### MICAH's 2023-24 Legislative Priorities Include:

- 1. Ensure the voice and power of people who have experienced homelessness and or housing crises are at every decision make table, design, implementation, evaluation of homeless programs and housing.
- 2. Work with families impacted by Lead Poisoning on Lead Safe Homes program implementation, to protect our children from lead paint poisoning.
- 3. Racial Equity and protection of Civil Rights in all Homeless and Housing Programs and support systems.
- 4. Preserve and create safe, decent accessible affordable housing (rental, shared, & homeownership) for people with incomes under 30% median income.
- 5. Support livable incomes for people who are employed, unemployed and on public assistance. Universal Basic Income, Child Tax Credits, Renter's Credit, Rental Assistance.
- 6. Ensure we are a welcoming community in creating housing opportunities that provide second chances and mercy for those who have struggled with addiction, mental and/or physical health, criminal, and/or rental issues.
- 7. MICAH will be actively involved with Homes For All process in developing and passing the 2024 Session priorities.

### **FEDERAL POLICY**



### **Bring America Home NOW! Campaign**

The National Coalition for the Homeless is spearheading Bring America Home NOW:

A Comprehensive Grassroots Campaign to End Homelessness in the U.S.

Led by people who have themselves experienced homelessness, we will focus on the passage of federal legislation aimed at addressing the interconnected solutions to the decades-long epidemic of homelessness in the United States.

### The campaign focuses on 6 major policy areas:

- **1. Housing** is a basic human right.
- **2. Health** and homelessness are inextricably linked: a safe, stable home is the prerequisite of health and well-being.
- **3. Livable incomes** are essential to prevent and homelessness to ensure stability in housing.
- **4. Education and training** can play a critical role for children, youth, and adults in equipping people with the knowledge and skills needed for economic mobility.
- **5. Civil Rights** Homelessness is a civil rights issue. People experiencing homelessness should not be criminalized or victims of hate crimes.
- **6. Racial Equity** Homelessness is a racial justice issue in the United States and racial equity is a key housing justice.



### **FEDERAL POLICY**



#### **IMMEDIATE REQUESTS**

Ensure the highest level of funding for housing in the FY24 spending bill.

#### **IMMEDIATE THREATS**

Push back against anti-homelessness rhetoric and legislation at the federal, state, & local level.

### LONG TERM SOLUTIONS Unhoused Bill of Rights

The legislation calls on the Department of Health and Human Services (HHS) to declare the unhoused crisis a public health emergency and calls for rigorous federal investments into homeless assistance programs, affordable housing initiatives, and wraparound services that keep people permanently housed.


### **Ending Homelessness Act (H.R.4496)**

Establishes a universal voucher program to ensure every eligible household can receive rental assistance. Provides \$10.5 billion to build homes affordable to people with the greatest needs Bans source of income discrimination and provides funding for fair housing enforcement.
